Your Affiant is Inspector Brittany Jordan with the Office of Inspector General (OIG) for the Florida Department of Corrections (FDC), and the defendant is Inmate Phillip Clayton DC# B06610 (Clayton) who is currently housed at Columbia Correctional Institution (CCI). Your affiant has investigated a Battery on a Law Enforcement Officer, while Clayton was housed at CCI.

On January 9, 2020, Clayton was housed in K-Dormitory at CCI. Lieutenant Jeremy Wilburn (Wilburn), Correctional Officer Shomari Denson (Denson) and [REDACTED] were present in K-Dormitory due to an inmate (Clayton) possibly being under the influence of an unknown substance. Security staff attempted to place Clayton in hand restraints when he snatched away; therefore, physical force was utilized to restrain him. After Clayton was assisted to his feet by Wilburn and Denson, he spit at [REDACTED] striking the left cheek of her face. Wilburn and Denson testified similarly that they observed Clayton spit on the left cheek of [REDACTED] face.

Your Affiant respectfully submits probable cause has been established Clayton did commit the violation of (1) count of Battery on a Law Enforcement, violation of § 784.07(2)(b) Florida State Statue in Columbia County, Columbia Correctional Institution, on January 9, 2020. Your Affiant respectfully requests a warrant be issued for Clayton for one (1) count of § 784.07(2)(b), the laws relating to Battery on a Law Enforcement Officer.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
