The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 16 th day of February, 2019, at approximately 4:40 <input type="checkbox"/> a.m. <input checked="" type="checkbox"/> p.m. at <u>Tomoka Correctional Institution located at 3950 Tiger Bay Road in Daytona Beach, FL</u> within <u>Volusia</u> County, violated the law and did then and there:					
Intentionally and unlawfully batter the Victim, Correctional Officer [REDACTED] a uniformed correctional officer employed by the Florida Department of Corrections, by causing a food tray to strike her in the face and chest against her will. [REDACTED] was on-duty and performing her official duties at the time of the battery.					
Your affiant is Inspector Jonathan Warren of the Florida Department of Corrections, Office of the Inspector General.					
On February 16, 2019 at approximately 4:40pm, [REDACTED] a uniformed correctional officer of the Florida Department of Corrections, was performing her official duties by supervising the feeding of the Evening Meal in the north dining room of Tomoka Correctional Institution. She observed the Defendant, Inmate Raymond Lewis, speaking or attempting to speak with other inmates in an attempt to obtain more food. [REDACTED] spoke with Inmate Lewis about the rule violation.					
Inmate Lewis was holding a hard plastic food tray in his left hand while [REDACTED] was speaking with him. [REDACTED] reported that

placed his hands behind his back and faced a nearby wall. He was handcuffed by Sergeant Heather Pheneger with the assistance of [REDACTED] and Donna Ashley.

[REDACTED] on February 16. [REDACTED] Sergeant [REDACTED] was photographed by Correctional Officer Ryan Eckersen on February 16.

The incident was recorded by the video camera in the dining room. Sergeants Pheneger and Ashley witnessed the battery but could not clearly hear the conversation that preceded it. Inmate Romer Williams heard the conversation between [REDACTED] and Inmate Lewis. Williams reported that [REDACTED] was speaking with Inmate Lewis about a rule violation. Williams theorized that Inmate Lewis felt disrespected by [REDACTED]. Inmate Williams did not witness the battery.

Inmate Lewis was interviewed at approximately 9:33am on February 20. When he was informed of the reason for the interview, he stated, "A battery? I threw the tray on her. That's what I did." Inmate Lewis was instructed to stop speaking and advised of his Miranda Rights. Inmate Lewis requested an attorney and was not asked any questions about the incident.
