Your Affiant is Inspector Scott Gambel with the Office of Inspector General for the Florida Department of Corrections, and the defendant is Inmate Vance Lake who was assigned to Columbia Correctional Institution Annex. Your affiant has conducted an investigation into a Possession of Contraband.						
On May 24, 2019, Sergeant Brandon Clemens along with Lieutenant Dustin Phillips conducted a search of the cell which housed Inmate Vance Lake. After the cell search, a hand-held metal detector was used on Inmate Lake which alerted to the presence of a foreign object in the buttocks area of Inmate Lake. Inmate Lake was placed into a dry cell where Inmate Lake produced an L8Star cellular telephone by defecating. The phone was wrapped in tissue paper and clear plastic wrap.						
Your Affiant respectfully submits probable cause has been established indicating Inmate Vance Lake did commit the violation of Possession of Contraband in violation of FSS 944.47 (1)(c) in Columbia County, Columbia Correctional Institution Annex on May 24, 2019. Your Affiant respectfully requests a warrant be issued for Inmate Vance Lake for one count of FSS 944.47 (1)(c), Possession of Contraband.
