Your affiant has conducted an investigation into Introduction of Contraband into a Secure Facility.

On June 11, 2019, Inmate Gomez was pulled out his assigned cell for a cell search and pat search. Sergeant Joshua Kramer, Sergeant Jason Garland, and Sergeant Kevin Wallace conducted this search. A search of Inmate Gomez's person, utilizing a handheld metal detector, was conducted by Sergeant Kramer. The handheld metal detector alerted to the front waistband area of Inmate Gomez. Sergeant Kramer pat searched that area of Inmate Gomez and discovered a small cell phone that was concealed in a sewn in pocket of Inmate Gomez's boxer undergarment. The contraband phone was recovered and is stored as evidence under the control of the OIG. Sworn witness testimony was obtained from Sergeant Garland and Sergeant Wallace who witnessed the discovery of the phone by Sergeant Kramer.

Inmate Gomez refused to make a statement to your Affiant.

Your Affiant respectfully submits probable cause has been established indicating Inmate Gomez did commit the violation of Introduction of Contraband into a Secure Facility in violation of FSS 944.47(1)(a)6 in Columbia County, Columbia Correctional Institution Annex on June 11, 2019 Your Affiant respectfully requests a warrant be issued for Inmate Gomez for one count of FSS 944.47(1)(a)6.
