On July 13, 2020, during a scheduled Office of Institutions Canine Operation, Captain Justin McDowell's canine alerted to the vehicle driven by Ms. Jackson and was parked in the parking lot of WCI. Captain McDowell obtained consent from Ms. Jackson to search her car and the search of Ms. Jackson's car revealed a prescription style bottle containing 44 pills.
