TO WIT: SENIOR INSPECTOR PATTERSON (AFFIANT) WAS NOTIFIED, BY INSPECTOR SUPERVISOR KATOUREE JACKSON, OF AN INCIDENT CONCERNING THE POSSIBILITY OF INTRODUCTION OF A NARCOTIC AT DCI. UPON BEING ADVISED OF THE INCIDENT SI PATTERSON RESPONDED TO DCI. UPON ARRIVAL, SI PATTERSON MET WITH DCI COLONEL GEORGE RIOS. COLONEL RIOS ADVISED SI PATTERSON OF THE INCIDENT AND IDENTIFIED CORRECTIONAL OFFICER ARNIA WILLIAMS (COMPLAINANT) AS THE ENTRANCE OFFICER WHO DISCOVERED THE UNKNOWN SUBSTANCE INSIDE A CORRECTIONAL COAT WORN BY THE DEFENDANT.

DURING A SWORN, RECORDED INTERVIEW OFFICER WILLIAMS MADE THE FOLLOWING STATEMENT: OFFICER WILLIAMS STATED BEFORE SHE DEPARTED DCI, SHE WAS ASKED TO COVER THE DUTIES OF THE ENTRANCE BY ANOTHER CORRECTIONAL OFFICER, WHILE THE OTHER OFFICER HEATED UP FOOD IN THE CONTROL ROOM. OFFICER WILLIAMS STATED, AT APPROXIMATELY 12:15 P.M., THE DEFENDANT ENTERED THE ENTRANCE SALLY PORT TO DCI TO BE CLEARED FOR ENTRANCE UNTO DCI. DURING THE ENTRANCE PROCESS, OFFICER WILLIAMS STATED THE METAL DETECTOR WENT OFF AS THE DEFENDANT PASS THROUGH IT. SHE SAID AFTER THAT ATTEMPT, THE DEFENDANT REMOVED KEYS FROM HIS POCKET AND PLACED THEM ON THE X-RAY MACHINE. AFTER ANOTHER PASS THROUGH THE METAL DETECTOR, OFFICER WILLIAMS STATED NOTHING WAS DETECTED AND SHE PROCEEDED WITH THE ENTRY PROCESS. SHE STATED THE DEFENDANT HANDED HER HIS CORRECTIONS COAT AND SHE DISCOVERED MULTIPLE ITEMS WRAPPED IN BLACK TAPE. SHE STATED THE DEFENDANT MENTIONED THE ITEMS WAS CIGARETTES AND THEN SAID IT WAS GUM. AFTER THE DISCOVERY, OFFICER WILLIAMS RELAYED THE INFORMATION TO THE CONTROL ROOM SERGEANT, SERGEANT TITIANA DIXON, THEREAFTER, THE SHIFTS OFFICER-IN-CHARGE WAS NOTIFIED, CAPTAIN JULIAN RODRIGUEZ.

POST INTERVIEW OF THE COMPLAINANT, SI PATTERSON MET WITH CAPTAIN RODRIGUEZ. CAPTAIN RODRIGUEZ TRANSFERRED THE CUSTODY OF THE ALLEGED SYNTHETIC CANNABIS TO SI PATTERSON. SI PATTERSON, THROUGH LAW ENFORCEMENT EXPERIENCE AND KNOWLEDGE, IDENTIFIED THE SUBSTANCE AS SYNTHETIC CANNABIS (COMMONLY KNOWN AS K2). THE SUBSTANCE APPEARED AS GREEN LEAFY MATERIAL. SI PATTERSON WEIGHED THE SUBSTANCE, WHICH HAD A COMPLAINED WEIGHT OF (114) GRAMS. THE SUBSTANCE WAS PACKAGED IN (4) SEPARATE PLASTIC BAGS. ALSO, CAPTAIN RODRIGUEZ ADVISED SURVEILLANCE VIDEO OF THE INCIDENT WAS AVAILABLE. SI PATTERSON REVIEWED THE VIDEO; THE CONTENT OF THE RECORDING WAS CONSISTENT WITH OFFICERS WILLIAMS'S STATEMENT.

AFTER REVIEWING THE SURVEILLANCE VIDEO, SI PATTERSON AND SENIOR LAW ENFORCEMENT JOHN ANNARUMMA CONDUCTED A POST-MIRANDA INTERVIEW OF THE DEFENDANT. DURING THE INTERVIEW, THE DEFENDANT MADE THE FOLLOWING STATEMENT: THE DEFENDANT ADMITTED [REDACTED]
