84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:
Your Affiant is Senior Inspector Jerry Basford of the Office of the Inspector General, Florida Department of Corrections.
Your Affiant has probable cause to believe on January 25, 2021, Inmate François Nicolas (DC X80913) in the County of Washington and the State of Florida, did commit the offence of Battery of a Law Enforcement Officer, in violation of s. 784.07 (2)(b), Fla. Statute, when Inmate Nicolas did actually and intentionally touch or strike Correctional Officer while Officer was clothed in a correctional officer's uniform and engaged in the lawful performance of her duties and while Inmate Nicolas knew Officer was a correctional officer.
On the aforementioned date, at approximately 1:57 a.m., Officer was making rounds in D1-dormitory at Northwest Florida Reception Center (NWFRC), waking up food service inmates to report for their job assignments. At approximately 1:58 a.m., Officer passed by Inmate Nicolas as he appears to be making his bed. As Officer walked past Inmate Nicolas, there was no interaction between Inmate Nicolas and Officer around her neck with his right arm in a choke hold and wrestled her forward to the ground. After a brief struggle on the floor, another inmate intervened separating Inmate Nicolas from Officer
In a sworn interview Officer
In a post-Miranda sworn interview, Inmate Nicolas indicated he works evening shift in food service. After he returned to the dormitory on the evening of January 24, 2021, he showered and at some point smoked synthetic cannabinoids and went to sleep. Inmate Nicolas recalled evening count occurring on January 24th prior to him falling asleep. When he awoke some time later and saw Officer walking through the dormitory he though she was conducting count again. Something told Inmate Nicolas he needed to grab Officer walked past him, buring Inmate Nicolas and Officer walked past him, buring Inmate Nicolas' interview he had no concept of the timeframes between the evening of January 24, 2021 and the morning of January 25, 2021.
The incident was captured on fixed wing video recording. The video of the incident supports the statements provided during this nvestigation.
