Your affiant is Senior Inspector H. K. Hutson of the Office of the Inspector General, Florida Department of Corrections.

Investigation reveals that, on 2-14-2021, at approximately 0830 hours, in F-dorm at Cross City CI, Main Unit, the defendant—Inmate Anthony Bellmon, DC# H16551—became angry when he was served a disciplinary report by security personnel. Inmate Bellmon then became disruptive to a point at which Officer [REDACTED] made contact with him and attempted to take Inmate Bellmon into custody so he could be escorted to the confinement dorm.

When the officer ordered the defendant to submit to handcuffs, the defendant became combative and began striking Officer [REDACTED] in his head, face and torso, with his closed fists. [REDACTED] was also present, and attempted to assist in the apprehension of the defendant. Inmate Bellmon continued to resist and then attacked [REDACTED] by striking [REDACTED] upon his head, face and torso with his closed fists. Inmate Bellmon then tackled [REDACTED] and continued striking [REDACTED] with his closed fists. [REDACTED] deployed his Taser in attempt to bring the inmate into compliance, but with little to no effect. [REDACTED] then observed that Inmate Bellmon had a 4.25" x 1", homemade, knife-type weapon in his hand. [REDACTED] then sprayed the inmate with chemical agents after which, Inmate Bellmon complied with verbal orders, dropped the weapon and submitted to restraints. As of the time of this writing, it does not appear that the weapon was used on either officer.

The entire incident was recorded on FDC surveillance video.

Both victim officers were in full uniform of correctional officer of the Florida Department of Corrections at the time of the incident.

Senior Law Enforcement Inspector Harry Hutson responded to Cross City CI and initiated a criminal investigation of the incident. Upon viewing video footage, Inspector Hutson determined that sufficient probable cause for arrest had been established to arrest Inmate Bellmon on two (2) counts of Battery of a Law Enforcement Officer, and one (1) Count of Possession of Contraband in a State Correctional Facility. The defendant was later transported to Dixie County Jail for booking on the listed charges.
