84. NAPRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The underspried certifies and sweets that he/alse has just and resconable grounds to believe that the heratorie named defendent did commit the violations of law as stated above and the factual basis for this benefits as follows:

Your Affiant is Senior Inspector William "Eddie" Dalton of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that in or about March 2020, through June 2020, Correctional Officer Jarvaneschia Wiggins committed the criminal offence Unlawful Compensation (4 counts), in violation of § 838.016(1), Florida Statute, when Officer Wiggins did receive (4) money transfers (\$1600.00) to personally benefit Officer Wiggins, for the non-performance of her lawful duty, to wit: the overlooking, permitting, and/or enabling the violation of Florida criminal laws and Departmental disciplinary rules, including engaging in a prohibited personal relationship with inmate(s);

Your Affiant has probable cause to believe that Officer Jarvaneschia Wiggins, committed the criminal offence of Introduction of Contraband (Written Communication) into a State Correctional Institution (3 counts), in violation of § 944.47 (1) (a)(1) Florida Statute, when Officer Jarvaneschia Wiggins did actually and intentionally digitally transmit unauthorized written and recorded communications into the secure perimeter of a State Correctional Institution to Inmates Aukevious Hendrieth DC#J54090, Samuel Turner DC#B15312, and Eric Duran DC#B04865.

Your Affiant also has probable cause to believe Officer Wiggins did commit the criminal offence of Unlawful Use of a Two-way Communication Device (3 counts), in violation of § 934.215, Florida Statute, when Officer Wiggins did utilize her personal cellular telephone number(s) and statute, when Officer Wiggins did utilize her personal cellular telephone number(s) and 334-591-0374, which evidence indicated was in possession of several inmates confined within the secure perimeter of Jackson Correctional Institution. Evidence also indicated Officer Wiggins utilized her cellular telephone to send and receive unauthorized written or recorded communication to inmates Aukevious Hendrieth DC#J54090 and Samuel Turner DC#B15312 via J-pay. Messages also Indicated Officer Wiggins utilized her personal cellular telephone to coordinate meetings with known associates of inmates in Galnesville Fforida.

Your Affiant also has probable cause to believe Officer Wiggins did commit the criminal offence of interference with Prisoners, in violation of § 944.39, Florida Statute when Officer Wiggins began a personal relationship with Inmates Eric Duran DC#B04865, Aukevious Hendrieth DC#J54090, and Samuel Turner DC#B15312 while the Inmates were under the care, custody, and control of the Florida Department of Corrections, and by doing so has allowed said inmates to violate the rules of the Florida Department of Corrections and the laws of the State of Florida, including communication through unauthorized means, possession of unauthorized items (contraband cellular telephones, possession of contraband, and other unauthorized Items), all without reporting her inappropriate relationship and inmates' actions. These unauthorized actions pose a threat to other staff and inmates.

On June 8, 2020, Sergeant Aaron Kirkland was assigned as the Security Threat Group (STG) coordinator at Jackson Correctional Institution. According to his incident report, Sergeant Kirkland was monitoring inmate Duran's recorded telephone calls with his sister, Alejandra Duran, when he discovered a prohibited three-way telephone call. Sergeant Kirkland identified Officer Wiggins' voice talking with Inmate Duran during the three-way telephone call. During the three-way telephone call, Officer Wiggins made the statement "Statement Stop baby". Sergeant Kirkland advised Officer Wiggins has a small child with the name "Statement".

On June 8, 2020, Colonel Jerry Shuler was assigned as Chief of Security at Jackson Correctional Institution. Colonel Shuler was reviewing live fixed wing video footage when he observed Officer Wiggins return to her personal vehicle after receiving her post assignment. Colonel Shuler and Major James Crutchfield conducted a post inspection of the perimeter vehicle Officer Wiggins was driving. During the post inspection, Officer Wiggins was in possession of two cellular telephones, which is strictly prohibited per Florida Department of Corrections policy.

On June 8, 2020, Officer Wicolns provided a digitally recorded sworn post-Miranda statement advising	
During the interview with Officer Wiggins, your Affiant played a Securus telephone call between inmate Duran and Ms. Duron place on February 28, 2020. During the telephone call, Ms. Duran connected a three-way telephone call to Officer Vicellular telephone. Officer Wiggins acknowledged Wiggins acknowledged	
Officer Wiggins advised	

Officer Wiggins provided your Affiant with the security code for her LG cellular telephone and allowed your Affiant to review the data on the device. White reviewing the data on Officer Wiggins' cellular telephone, it was noted Officer Wiggins had Inmate Duran's contact information saved as "My King" with a photograph of Inmate Duran in her contacts.

D#: 22512 According to Officer Wiggins, Inmate Duran's contraband cellular telephone number is 662-392-9622. Officer Wiggins
Officer Wiggins also allowed your affiant to review her text messages to "My King" (Inmate Duran). The last text message was from "My King" to Officer Wiggins. The text message to Officer Wiggins said: "So we got smoke?" Officer Wiggins further stated
Officer Wiggins allowed your Affiant to review and photograph the CashApp money transaction(s) sent to Officer Wiggins via her cashtag, \$jarawiggins. Your Affiant observed a CashApp money transaction from cashtag, \$rodeogrounds for \$500.00 dollars. Officer Wiggins indicated she did receive training upon becoming employed with Jackson Correctional Institution related to policy and procedures, rules and regulations, Florida State Statutes, and that staff offender relationships are strictly prohibited. Inspector Dalton took possession of Officer Wiggins LG smart telephone and provided her with a property / evidence receipt.
On March 16, 2021, at approximately 8:00 a.m. CST, your Affiant made contact with Ms. Duran via telephone number 305-562-5957. Ms. Duran advised her brother is Inmate Eric Duran, DC#804865, and he was previously housed at Jackson Correctional Institution.
Ms. Duran advised she is familiar with Jarvaneschia Wiggins as she and inmate Duran became involved in a romantic relationship while Jarvaneschia Wiggins was a Correctional Officer at Jackson Correctional Institution and Inmate Duran was housed at Jackson Correctional Institution.
Ms. Duran advised she sent Officer Wiggins money via CashApp on behalf of inmate Duran. Ms. Duran also advised she knew inmate Duran was in possession of a cellular telephone while incarcerated at Jackson Correctional Institution. Ms. Duran advised she paid inmate Duran's contraband cellular telephone bill for a month while he was incarcerated at Jackson Correctional Institution. Ms. Duran indicated inmate Duran told her that he and Officer Wiggins met in Miami years prior to inmate Duran becoming incarcerated.
Ms. Duran advised she thought inmate Duran and Officer Wiggins were boyfriend and girlfriend and nothing more.
Records were obtained through subpoens duce tecum from Square inc. the marketing company of the money transfer app, CashApp, for cashtag, \$jarawiggins. Square records confirm Jarvaneschia Wiggins, date of birth telephone number, and address is the account holder associated with the CashApp cashtag \$jarawiggins.
Square records confirm, Officer Jarvaneschia Wiggins received four (4) money transfers from cashapp, \$wipetini. The money transfers from \$wipetini occurred on April 18, 2020 (\$800.00), April 22, 2020 (\$200.00), May 1, 2020 (\$100.00), and May 9, 2020 (\$500.00) for a total of \$1600.00 dollars.
Records were obtained from Square Inc, the marketing company of the money transfer app, CashApp, for cashtag \$wipetini and \$rodeogrounds. The cashtags \$wipetini and \$rodeogrounds are both associated with the same CashApp account belonging to Inmate Duran's sister, Alejandra Duran.
Based on Square records, your Affiant was able to identify the four (4) CashApp money transactions received by Officer Wiggins were from inmate Duran's family.
Records were obtained from Verizon Wireless, via subpoens duces tecum, including subscriber information and call detail records for Officer Wiggins' personal cellular telephone number assigned to a prepald device and has no subscriber information. Verizon records indicate on June 7, 2020 and June 8, 2020, Officer Wiggins cellular telephone number had approximately eight (8) incoming, outgoing, attempted calls, and/or text messages to and from contraband cellular telephone number Approximately seven of the eight contacts with the contraband cellular telephone number were while Officer Wiggins was on duty and working as a Correctional Officer, assigned to perimeter security (roving patrol).
Records were obtained from AT&T wireless including subscriber information and call detail records for Officer Wiggins cellular telephone number AT&T records reflect Officer Wiggins communicated frequently with 305-562-5957. According to Florida Department of Corrections records, the telephone number is associated with Alejandra Duran. According to AT&T records, from May 22, 2020, through June 8, 2020, Officer Wiggins' celtular telephone number had approximately four hundred thirty-four (434) incoming, outgoing, attempted calls, and/or text messages with Ms. Duran's telephone number, some of which occurred while Officer Wiggins was on duty and working as a Correctional Officer, assigned to perimeter roving patrol.
AT&T records reflect that Officer Wiggins communicated with 386-983-8379. According to Florida Department of Corrections

AT&T records reflect that Officer Wiggins communicated with 386-983-8379. According to Florida Department of Corrections records, the telephone number is associated with Inmate Aukevious Hendrieth's mother, Lawun Banks. According to AT&T records, from May 22, 2020 through June 9, 2020, Officer Wiggins' telephone number had approximately ninety-eight (98) incoming, outgoing, attempted calle, and/or text messages to and from Ms. Banks' telephone number, some of which occurred while Officer Wiggins was working and assigned to perimeter roving patrol.

Records were obtained from AT&T wireless including subscriber information and call detail records for contraband cellular telephone number AT&T records indicate Officer Wiggins is the subscriber of the account associated with the contraband cellular telephone number

Your Affiant applied for, received, and executed a search warrant on Officer Wiggins LG cellular telephone with associated
