84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned cartifies and sweets that he/site has just and resconable grounds to believe that the instable commit the violations of law as stated above that the factual basis for this belief is as follows:

Your Afflant is Senior Inspector William Dalton of the Office of the Inspector General, Florida Department of Corrections.

Your Afflant has probable cause to believe former Certified Nursing Assistant Krystal Sanders, in the County of Jackson and the State of Florida, did commit two (2) criminal offenses of Introduction of Contraband into a State Correctional Institution (Communication), in violation of s. 944.47 (1)(a)(1) Florida Statute, when Krystal Sanders did actually and intentionally introduce, through unauthorized channels, into the secure perimeter of a State Correctional Institution, electronically transmitted and/or recorded communication, images, and videos to inmates housed at Jackson Correctional Institution, Jackson County, Florida. Probable cause also exists Krystal Sanders did commit two (2) counts of criminal offense of Unlawful Use of a Two-way Communication Device, in violation of s. 934.215 Florida Statute, when Krystal Sanders used an electronic communication device to introduce contraband communication to inmates housed at Jackson Correctional Institution, Jackson County, Florida. Lastly, Krystal Sanders committed two (2) counts of the criminal offense of Interference with Prisoners, in violation of s. 944.39 Florida Statute, when Krystal Sanders engaged in a personal relationship with Inmates housed at Jackson Correctional Institution, Jackson County, Florida, and while doing so allowed the inmates to violate laws of the State of Florida and rules of the Department of Corrections.

Krystal Sanders began her employment at Jackson Correctional Institution as a Certified Nursing Assistant with Centurion of Florida (Medical service contractor for Florida Department of Corrections) on or about March, 2020. Krystal Sanders worked in the medical department as well as various dormitories during her employment. On December 22, 2020, Krystal Sanders resigned from the Centurion of Florida.

On or about December 21, 2020, (prior to Krystal Sanders' resignation) Sergeant Aaron Kirkland (Sergeant Kirkland) who is assigned to the Security Threat Group (STG) was reviewing emails of at Jackson Correctional Institution, Jackson County, Florida, when he discovered what appeared to be a flictitious J-pay account that was created on July 14, 2020, in the name Rose Gonzalez, account iD "Rose Gonzalez" (Krystal Sanders) was communicating with inmates upon further inspection of "Rose Gonzalez" J-pay account, Sergeant Kirkland observed videos and photographs that were sent from "Rose Gonzalez" to inmates and Davial. The videos and photographs were of Krystal Sanders who works in the nursing department at Jackson Correctional Institution. The videos and photographs showed a clear depiction of Krystal Sanders face.

J-pay records revealed on July 14, 2020, a J-Pay account was created in the name Rose Gonzalez. The customer ID number is The J-Pay account had an address of 4581 SW 137th CT, Miami, FL 33175, telephone number of and an email address of diamond.rose.gonzalez@gmatl.com.

J-Pay records revealed during Krystal Sanders' employment with Centurion of Florida (March, 2020 through December 22, 2020), she sent five hundred sixty-six (568) and received four hundred ninety-seven (497) unauthorized electronic communications (J-pay) with Inmate and Inmate Davila who were incarcerated at Jackson Correctional Institution and under the supervision of the Florida Department of Corrections.

On or about July 14, 2020, through November 11, 2020, J-Pay records revealed, the unauthorized electronic communication via J-pay between "Rose Gonzalez" (Krystal Sanders), Inmate and Inmate Davila was sexuality explicit and romantic in nature. "Rose Gonzalez" (Krystal Sanders) had not sent any photographs or videos through J-pay.

On November 11, 2020, at approximately 4:37 p.m., J-Pay records revealed, "Rose Gonzalez" (Krystai Sanders) sent unauthorized electronic communication via J-pay to inmate who was housed at Jackson Correctional institution. The video was clear and showed Krystal Sanders' uncovered face.

On November 12, 2020, at approximately 7:55 a.m., "J-Pay records revealed, "Rose Gonzalez" (Krystal Sanders) sent unauthorized electronic communication via J-pay to inmate Davila, who was housed at Jackson Correctional Institution. The video was clear and showed Krystal Sanders' uncovered face.

Contact was made with Jackson Correctional Institution Warden Scott May (Warden May) and former Warden Christopher Brannon (Warden Brannon). Both Warden May and Warden Brannon advised Krystal Sanders did not disclose inmate or Inmate Davial as being a relative or being in a personal relationship with either inmate. Warden May and former Warden Brannon further advised neither had not received or approved any requests for communication or visits to any inmate(s) from Krystal Sanders.
