The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:
 On the 9th day of August 2021, at 11:59 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Senior Inspector Scott Gambel (*Inspector Gambel*) with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Sergeant Matthew Spivey (*Sergeant Spivey*) who was assigned to Suwannee Correctional Institution. Your Affiant has conducted an investigation into the Possession/Introduction of Contraband.

On August 10, 2021, Sergeant Spivey was reporting for duty at Suwannee Correctional Institution. Sergeant Spivey entered the control room and was subjected to a random pat search by Sergeant John Greene (*Sergeant Greene*). During the pat search, Sergeant Greene located 3 capsules of an unknown substance in the right hip pocket of Sergeant Spivey. The capsules were wrapped in plastic and contained a white crystal substance. Sergeant Spivey admitted the substance inside the capsules was Methamphetamine.

The substance inside the capsules was field tested by Inspector Gambel, using a Methamphetamine test kit which showed a positive result.

Sergeant Spivey was questioned under Miranda by Inspector Gambel. Sergeant Spivey admitted [REDACTED]

Your Affiant respectfully submits probable cause has been established indicating Sergeant Matthew Spivey did commit the violation of Possession/Introduction of Contraband in violation of FSS 944.47 (1)(a)4 and Possession of Methamphetamines in violation of FSS 893.13, in Suwannee County, Suwannee Correctional Institution on August 10, 2021.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
