84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Law Enforcement Inspector Lee Martin with the Florida Department of Corrections (FDC), Office of the Inspector General. Your Affiant has probable cause to believe that on August 24, 2021, at Century Correctional Institution, 400 Tedder Rd., Century, Escambia County, Florida, Dickale Cothrell did commit (1) count of the criminal offense of Introduction of Contraband into a State Correctional Facility, in violation of s. 944.47(1)(a)(1) Fla. State Statute and (1) count of interference with prisoners, which violates Fla. State Statute 944.39.

Your Affiant took a sworn recorded statement from Florida Department of Corrections Sergeant Jamie Sanders and Officer Joseph deGraaf who stated on August 24, 2021, while performing a search for a black male subject who was trespassing onto state of Florida property occupied by Century Correctional Institution (CENCI). FDC K-9 Sergeant Sanders and FDC K-9 Officer deGraaf saw the black male, later identified as Dickale Cothrell, on the east side of CENCI. CENCI Warden John Kolodziej enacted a lockdown of CENCI which halted all inmate movement, inmate work assignments (on and off property) and inmate educational programs.

Sergeant Sanders and Officer deGraaf waited for permission to trail the suspect by which time Suspect Cothrell was seen at a further east location. Sergeant Sanders and Officer deGraaf moved to that location and ran the track where Suspect Cothrell was lying down in the woods. Suspect Cothrell was detained until Deputy Ty Brewton, Deputy Eric Anderson and Inspector Lee Martin arrived. At that time, Suspect Cothrell was arrested for interference with prisoners. Moments later, K-9 Sergeant Sanders' dog ran the track of Suspect Cothrell which took them back to the exact location that Sergeant Sanders and Officer deGraaf first saw Suspect Cothrell. It was there that Sergeant Sanders located a package ready for introduction. The package was taken back to Inspector Lee Martin's office and unwrapped. The contents included (1) silver At&t cellphone; (1) blue At&t cell phone; (1) gray LG cell phone; 23.8 grams of suspected synthetic cannabis; 111.5 grams of cigarettes; (1) cell phone plug and (2) cell phone charging wires.

Suspect Cothrell was seen on CENCI property at approximately 7:51 a.m., on August 24, 2021, behind the CENCI warehouse, via fixed video. A search ensued, performed by security personnel and Inspector Lee Martin. Suspect Cothrell had no legal right or approved authorization to be on CENCI grounds.

Your Affiant respectfully submits probable cause has been established to conclude Dickale Cothrell, date of birth August 30, 1985, did commit the criminal violation of Introduction of Contraband into a State Correctional Facility, in violation of s. 944.47(1)(a)(1) Florida Statute and interference with prisoners, in violation of s. 944.39 Florida Statute.
