84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Inspector Steven Lee of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe Lovette Aubrey Morgan, a Correctional Officer Sergeant at Northwest Florida Reception Center in Chipley Florida did commit the criminal offense of Conspiracy to Introduce Contraband into a state institution, to wit controlled substances in violation of FS 777.04 (1)/ 944.47(1)(a)(4)) planning and then concealing Methamphetamines "ICE" along with Methylendioxyamphetamine "Molly" on his person to introduce into a secured Correctional Facility.

Your Affiant has probable cause to believe Lovette Aubrey Morgan, a Correctional Officer Sergeant at Northwest Florida Reception Center in Chipley Florida did commit the criminal offense of Unlawful Use of a Two-way Communication Device, in violation of FS 934.215 by using a two-way communication device (*cell phone*) in the furtherance of a crime

Your Affiant has probable cause to believe Lovette Aubrey Morgan, a Correctional Officer Sergeant at Northwest Florida Reception Center in Chipley Florida did commit the criminal offense of Unlawful Compensation for Official Behavior, In Violation of FS 836.016 by receiving compensation to introduce contraband into a secure correctional facility.

On the dates of January 31, 2021, February 8, 2021, February 20, 2021, April 12, 2021, April 13, 2021, April 27, 2021, and April 28, 2021, Sergeant Morgan did introduce both "ICE" and "Molly" into Northwest Florida Reception Center after meeting with an unknown black female at the Dollar General Store located in Vernon Florida, where Sergeant Morgan received packages approximately one inch in diameter and approximately 3 inches long. These packages, containing the aforementioned drugs, were wrapped in plastic and rewrapped in black electrical tape. Sergeant Morgan would then secure these packages to his person and enter Northwest Florida Reception Center, a secure Florida Department of Corrections Correctional Facility.

In a sworn Post Miranda recorded statement Sergeant Morgan admitted [REDACTED]

Sergeant Morgan indicated [REDACTED]

[REDACTED] These text messages along with telephone calls were confirmed by a Cellebrite data recovery performed on cellular number (863) 732-1716 which was recovered in Inmate Jefferson's cell at Northwest Florida Reception Center. The communications between Sergeant Morgan and Inmate Jefferson occurred on 16 different dates with each of these dates having multiple messages exchanged. Sergeant Morgan indicated during his statement, [REDACTED]

Your Affiant requests an arrest warrant be issued for Lovett Aubrey Morgan, DOB [REDACTED] LKA [REDACTED] for seven (7) counts of a violation of 838.016, the law relating to Unlawful Compensation or Reward for Official Behavior; seven (7) counts of a violation of 944.47(1)(a)(1), the law relating to Introduction of Contraband, Written or Recorded Communication; sixteen (16) counts of a violation of 934.215, the law relating to Unlawful Use of a Two-way Communication device.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
