COUNT 2: Conspiracy to Introduce Contraband into a State Institution (78 counts)

That Decca Howard Mosley, a Correctional Officer at Liberty Correctional Institution, between December 2020 and November 2021, did then and there knowingly accept monetary compensation (on 78 separate occasions), via Cash App money transfer, from inmate family members or inmates for the purpose of providing inmates contraband, while employed and on duty at Liberty Correctional Institution, contrary to Florida Statute 777.04(3)/944.47.

Your Affiant has documented his probable cause in a complaint affidavit attached to this document as EXHIBIT A; wherein, the above violations are further explained. Your Affiant swears that EXHIBIT A is true.

Your Affiant is Inspector Joseph Varnum with the Office of Inspector General for the Florida Department of Corrections (FDC). The defendant is Decca Howard Mosley (Sergeant Mosley) who is a certified FDC Correctional Employee assigned at Liberty Correctional Institution (LCI). Your Affiant has investigated an Introduction of Contraband case alleging Inmate Carl Green (Inmate Green) DC# E01723, conspired with Officer Mosley to introduce contraband into the secure perimeter at LCI.

Inmate Green testified, Sergeant Mosley conspired with him (Inmate Green) to introduce contraband into the secure perimeter at LCI, and in return Sergeant Mosley was being compensated via money transfers through Cash App. Inmate Green would transfer the monies to Theodore Payne (Payne, former inmate DC# J41100, former cell mate), utilizing Cash App account \$\$Teddyp88. Payne would then in turn transfer the money to Mosley's Cash App (\$God'sdaughter) account the same day or the next day. Inmate Green's testimony described how Sergeant Mosley smuggled the contraband into the institution and delivered the items to him (Inmate Green) inside the secure perimeter to be distributed to other inmates.

Subpoenaed Cash App records revealed Payne transferred the money to Sergeant Mosley for the contraband. Laketra Lofton (sister to Inmate Carlos Lofton DC# N09323) utilized Cash App account \$Ketra to send monies to Officer Mosley's Cash App. There were seventy-eight (78) transactions for \$28,050.00, transferred to Sergeant Mosley's Cash App account. These transactions were sent to Sergeant Mosley while Inmate Green and Inmate Lofton were housed in LCI, mostly in the dormitories where Sergeant Mosley worked. Some of the Cash App transactions had notes indicating the money being sent was for "Shawn", this alias was associated with Inmate Shawn Brown DC# Y47492, that was housed at LCI.

Cash App senders, inmates, inmate family members or former inmates, were contacted and confirmed the money they sent via electronic transfer, was bound for the Cash App in Sergeant Mosley's name.

Based on inmate and former inmate testimonies, and the Cash App subpoenaed information, Your Affiant respectfully submits probable cause has been established, Correctional Officer Sergeant Decca Howard Mosley did commit the offenses, seventy-eight (78) counts of Bribery in violation of §838.015(1), and seventyeight (78) counts Conspiracy to Introduce Contraband in violation of §777.04(3) / §944.47, in Liberty County, Florida, Liberty Correctional Institution. Your Affiant respectfully requests an arrest warrant be issued for Decca Howard Mosely B/F, DOB: for seventy-eight (78) counts of Bribery in violation of §838.015(1), and seventy-eight (78) counts Conspiracy to Introduce Contraband in violation of §777.04(3) / §944.47.
