Your Affiant is Inspector Heather Whitfield with the Office of Inspector General for the Florida Department of Corrections, and the Defendant is Officer Daniel McIntosh. Your Affiant has conducted an investigation into, Malicious Battery, Tampering with Evidence, and False Report at Suwannee Correctional Institution (SWCI).

On March 08, 2022, Inmate [REDACTED] was being escorted from SWCI Main Unit to the Annex for confinement after being found in possession of tobacco. Inmate [REDACTED] was being escorted by Officer Daniel McIntosh and Officer Artavius Morgan. Inmate [REDACTED] at SWCI Main Unit prior to arriving at the SWCI Annex [REDACTED]. After being placed in a holding cell for approximately 15 minutes Inmate [REDACTED] was then placed in a secured cell within the dorm. While the serving of lunch, a housing officer observed [REDACTED] and removed Inmate [REDACTED] from the cell [REDACTED].

The fixed wing video [REDACTED] was reviewed by your Affiant who observed Officer McIntosh entering into a holding cell with Inmate [REDACTED] who was restrained in hand restraints. Officer Morgan is seen holding the cell door shut with his body and foot while Officer McIntosh was inside. Officer McIntosh appeared back on camera after being in the holding cell with Inmate [REDACTED] for 30 seconds. [REDACTED] is visible on Officer McIntosh's right arm right above his gloves. Officer McIntosh, after visiting a bathroom, obtains a set of clean inmate clothing and is seen on camera providing Inmate [REDACTED] the clothing in the holding cell. Inmate [REDACTED] is then escorted out of a holding cell by Officer McIntosh and Officer Morgan and taken to a secure cell within the dorm. On camera, Inmate [REDACTED] is visibly [REDACTED] during the escort and [REDACTED].

Witness testimony from Inmate Armond Ricks DC# K56639, who is assigned to work in the area of the incident, testified that Inmate [REDACTED] upon entering the holding cell and that Inmate [REDACTED] exited

the holding cell [redacted] Inmate Ricks also indicated that he was ordered to clean up [redacted] and clothing in the holding cell by Officer McIntosh. This testimony is corroborated by the video that shows Inmate Ricks entering the holding cell for cleaning purposes, then entering and exiting the holding cell with a [redacted]. Inmate Ricks identified this bag as containing Inmate [redacted] clothing and the bag was left at the front door of the dorm. Pictures of the [redacted] clothes were obtained at the location where Inmate Ricks testified, he left them.

Officer McIntosh submitted an incident report stating that Inmate [redacted] was being escorted to confinement at the Annex. Officer McIntosh stated that he entered the holding cell to conduct a thorough search of Inmate [redacted] including a search of the band of his pants, undergarments and then had Inmate [redacted] remove his boots and socks to be searched, although he was only inside the holding cell for 30 seconds. Officer McIntosh stated Inmate [redacted] was secured in the cell without any incident and at no time did Officer McIntosh use force during the escort or search.

Your Affiant respectfully submits probable cause has been established indicating Officer Daniel McIntosh did commit the violation of Tampering with Evidence 918.13 (1)(a) and Malicious Battery 944.35 (3)(a)(1) and False Report 944.35 (4)(b) in Suwannee County, Suwannee Correctional Institution on March 8, 2022.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
