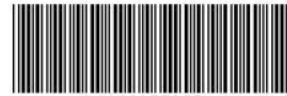

INTRODUCTION, REMOVAL, OR POSSESSION OF CONTRABAND.

ON AUGUST 25, 2022, FLORIDA CORRECTIONAL [REDACTED] (VICTIM) WAS ON-DUTY, LOCATED AT SFRC. THE VICTIM WAS PRESENT IN HIS ASSIGNED DUTY LOCATION, DRESSED IN THE DEPARTMENT'S CORRECTIONAL OFFICER UNIFORM.

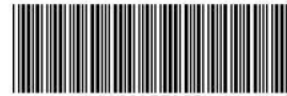
DURING THE MORNING MEAL, THE DEFENDANT WAS SEATED ALONE NEXT TO THE TABLET CHARGING STATION IN [REDACTED] DORMITORY WITHIN THE COMMON AREA (DAYROOM). AT APPROXIMATELY 06:35 A.M., THE DEFENDANT GOT UP AND RETRIEVED AN ITEM FROM THE CHARGING STATION, AFTER LOOKING OUT OF THE DAYROOM'S WINDOW. THE DEFENDANT PLACED THE ITEM IN HIS FRONT GROIN AREA AND BEGAN TO PROCEED TO THE STAIRCASE. BEFORE THE DEFENDANT COULD COMPLETELY LEAVE, [REDACTED] ORDERED THE DEFENDANT TO RETURN TO THE FIRST LEVEL OF THE DORMITORY, AS HE SEARCHED THE AREA THE DEFENDANT VACATED. THE DEFENDANT MOMENTARILY RETURNED; HOWEVER, THE DEFENDANT THEN STARTED TO RETREAT TOWARDS THE STAIRCASE BEFORE HE BEGAN TO RUN UP THE STAIRS. [REDACTED] PURSUED THE DEFENDANT, RUNNING UP THE STAIRS AFTER HIM. THE DEFENDANT RAN INTO HIS CELL [REDACTED] AND CLOSED/SECURED THE CELL DOOR. [REDACTED] MOTIONED TO HAVE THE DORMITORY CONTROL ROOM OFFICER UNLOCK THE DOOR. ONCE THE DOOR WAS UNLOCKED FROM A LATCHED POSITION, [REDACTED] PUSHED THE DOOR PARTIALLY OPEN. AS [REDACTED] ATTEMPTED TO FULLY OPEN THE DOOR, THE DEFENDANT PUSHED THE DOOR, SLAMMING THE DOOR ON [REDACTED] RIGHT HAND. AS [REDACTED] STRUGGLED TO ENTER THE CELL, HE OBSERVED THE DEFENDANT ATTEMPTING TO BREAK AND FLUSH A CONTRABAND CELL PHONE. [REDACTED] GRABBED THE DEVICE IN THE TOILET, AND THE DEFENDANT GRABBED THE DEVICE FROM [REDACTED] WHILE STRIKING HIS RIGHT HAND. BOTH OF THEM FELL TO THE FLOOR, WHERE THE DEFENDANT DELIVERED MULTIPLE STRIKES TO [REDACTED] TORSO. [REDACTED] RESPONDED BY STRIKING THE DEFENDANT BACK SEVERAL TIMES. [REDACTED] WAS THEN ABLE TO GAIN COMPLIANCE FROM THE DEFENDANT AFTER HE PULLED OUT HIS DART-FIRED CONDUCTED ELECTRICAL WEAPON (TASER). THE DEFENDANT WAS THEN RESTRAINED AND ESCORTED FROM THE DORMITORY BY RESPONDING PERSONNEL.
