Your Affiant is Lead Senior Inspector Chris McGauley (LSI McGauley) with the Office of Inspector General for the Florida Department of Corrections.

On October 23, 2022, LSI McGauley was at Columbia Correctional Institution (CCI) assisting Florida Department of Corrections (FDOC) K-9 staff and security staff with a check point and visitation. Captain Mike Roberts (Captain Roberts) conducted a free air sniff (with K-9 Taz) around the perimeter of a 1996 Mercury Marquis, Grey, Z68 7PS FL tag. The driver, Demitria Douglas (Douglas), visitor of Inmate Willie Rollins (Inmate Rollins) DC# G20869, drove onto state property with the car. K-9 Taz alerted to the vehicle for the presence of possible narcotics inside of it. After gaining consent to search from Douglas, Douglas signed a Consent to Search form.

Correctional Officer Fernando Sanchez (Officer Sanchez) (stationed at the Officer Building) and Correctional Officer Sergeant Adam Stephens (Sergeant Stephens) (stationed at in between the Officer Building and the Training Building) both testified similarly that they observed a small black object, in what appeared to be a brown bag, exit the passenger side window of Douglas' car. Sergeant Stephens located the oblong object, approximately three (3) inches in length, wrapped in black tape and was wrapped in a brown napkin (There were no other objects around this area except for what was located). Sergeant Stephens handed the package to LSI McGauley to secure, field test and photograph. The search of the car revealed several small what appeared to be burnt marijuana joints.

LSI McGauley attempted to conduct a sworn recorded interview of Douglas, post Miranda, but she refused to participate in the investigation.

Captain Jim Godwin (Captain Godwin) opened the package and the white powdery substance field test positive for Bath Salts. The Bath Salts was packaged, photographed and submitted for evidence in the TSL (Temporary Storage Locker) at CCI. LSI McGauley was present for the testing of the substance.

Your Affiant respectfully submits probable cause has been established Demitria Douglas did commit the violation of one (1) count of Possession of Controlled Substance (Bath Salts) in violation of § 893.13 and one (1) count, Introduction of Contraband (Conspiracy) in violation of § 777.04 (3)/944.47 (1)(c), and in Columbia County, Florida, Columbia Correctional Institution on October 23, 2022.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
