The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law:
 On the 22nd day of October 2022, at 1:24 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Alfred Hughes with the Office of Inspector General for the Florida Department of Corrections (FDC). The Defendant is Civilian Ashley Shrader (*Civilian Shrader*). Your Affiant has investigated Possession of a Controlled Substance (*Oxycodone*) while Civilian Shrader was at Hamilton Correctional Institution – (HCl) to pick up an inmate who was to be released today, on Saturday, October 22, 2022.

On October 22, 2022, your Affiant was at HCl conducting a planned checkpoint operation to deter the introduction of contraband into HCl. Lead Senior Inspector Chris McGauley (*LSI McGauley*) was also present. FDC Contraband Interdiction Unit (CIU) K-9 and security staff assisted your Affiant with the operation.

Civilian Shrader arrived at HCl at approximately 1:20 pm to pick up an inmate that was to be released today due to end of sentence. Civilian Shrader was driving a 2012 Ford Explorer, red in color, with a Florida Tag#2580GS. FDC CIU Correctional Officer Captain Jason Purdue (Captain Purdue) walked his K9 Lava around the vehicle to conduct a free air sniff. Captain Purdue indicated to your Affiant that a positive alert was displayed to the presence or odor of narcotics. Civilian Shrader freely admitted she had medical marijuana in her vehicle.



Your Affiant asked Civilian Shrader for permission to search her vehicle and its contents. Your Affiant positively identified Civilian Shrader by her Florida Driver's License #S636-013-85-762-0. Civilian Shrader agreed to the search and signed a Form DC1-804 Consent to Search. Your Affiant was present and observed the search. Captain Purdue and Correctional Officer Major Brett Handley (Major Handley) assisted your Affiant with the search. The medical marijuana was located and Civilian Shrader provided her Medical Marijuana Use Registry

Identification Card #P6XT6958 that is valid through 05/13/2023. Captain Purdue searched a grey in color purse that Civilian Shrader claimed was hers, while Civilian Shrader watched. Captain Purdue discovered a green in color pill bottle, with the label torn off. Inside the pill bottle were fifteen (15) oblong pills, white in color, with the imprint 7.5/325 on the side. The numbers identified the pills as 7.5 Oxycodone 325 Acetaminophen. Your Affiant observed the discovery of the pills. Civilian Shrader denied knowledge the pill bottle was in her purse and said she did not have a prescription for the pills.

Your Affiant conducted a recorded, sworn, post-Miranda interview of Civilian Shrader and noted the following: Civilian Shrader signed the Miranda Waiver Form DC1-848 after it was read to her. She admitted she observed Captain Purdue find the pill bottle and pills in her purse. She denied knowledge of the pills.

Your Affiant respectfully submits probable cause has been established to conclude Ashley Shrader did commit the criminal offense of Possession of a Controlled Substance Oxycodone without a prescription which is in violation of Florida Statute 893.13(6)(a) at Hamilton Correctional Institution located in Hamilton County, Florida on October 22, 2022.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
