WORRELL, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that CLAUDELLE PHILISTIN, on or about the 11th day of January, 2020, in said County and State, did, in violation of Florida Statute 893.13(6)(c), actually or constructively possess in excess of 10 grams of EUTYLONE (3,4-Methylenedioxy-alpha-ethylaminobutyrophenone), or a mixture containing EUTYLONE (3,4-Methylenedioxy-alpha-ethylaminobutyrophenone), a substance controlled by Florida Statute 893.03(1)(c)95.

COUNT THREE

MONIQUE H. NARRATIVE

The undersigned has probable cause to believe the above-named defendant, on the

of 11 day
of January, 2020, at approximately 2:30 a.m. p.m.
at 2925 Michigan Ave, Kissimmee, Florida 34744 (Zone District 7) in Osceola County did:

The Defendant is an inmate who was sentenced to the care, custody and control of the Florida Department of Corrections on June 13, 2017, for four years.

On January 11, 2020, at Florida Department of Corrections, Kissimmee Work Release Center in Kissimmee, Florida during the performance of her lawful duties, Sergeant Subernia Hackshaw observed Inmate Claudelle Philistin throw a clear bag containing rock like substances on his assigned inmate bed, next to a scale and calculator also on his bed. Hackshaw immediately retrieved these items and secured the inmate in handcuffs. The substance weighed 18 grams; Hackshaw tested the substance which tested positive for codeine.

Officer Warren Bolton who assisted Hackshaw reported, he told Philistin he knew the substance was Philistin's, which Philistin denied. However, Philistin said if he did have anything it was Molly.

Sergeant Hackshaw reported, she and Bolton returned to the holding cell to talk to Philistin and he said he was not going to waste her time, and indicated the substance was Molly.

On February 10, 2020, Miranda rights were read to Inmate Philistin, he declined to be interviewed and no questioning commenced.

FDLE lab report dated February 26, 2020, indicated the substance was Eutylone, a Schedule I drug. Therefore, making it illegal for Inmate Philistin to possess.
