The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following violation of the law: Between March and May 2023, AM, PM (Specify include facts constituting cause for arrest)

Your Affiant is Inspector Heather Whitfield with the Office of Inspector General for the Florida Department of Corrections (FDC). The Defendant is Correctional Officer Sergeant Tambrie Moore (Sergeant Moore) a current employee with FDC and assigned to Suwannee Correctional Institution as a certified correctional officer. Your Affiant initiated a Sexual Misconduct investigation after allegations were discovered that Officer Moore was involved in a relationship with Inmate [Redacted] DC# [Redacted] (Inmate [Redacted]) who is currently incarcerated with FDC. During this investigation it was also discovered Officer Moore was improperly communicating through unapproved means with Inmate [Redacted].

Sergeant Moore was assigned to D-Dormitory at Suwannee Correctional Institution Main Unit where Inmate [Redacted] was also assigned. Sergeant Moore was able to be in direct supervision and have access to Inmate [Redacted] during assigned working hours. Correctional Officer Lieutenant Steven Harris gave sworn testimony that Sergeant Moore and Inmate [Redacted] appeared to be too friendly in nature. Sergeant Moore was witnessed talking to Inmate [Redacted] in a casual manner on the Recreation Yard for long periods of time. Correctional Officer Sergeant Travis Williams gave sworn testimony that anonymous letters were also received concerning a possible inappropriate relationship between Sergeant Moore and Inmate [Redacted]. After witnessing the behavior that was suspicious and the anonymous letters, Inmate [Redacted] was transferred to the [Redacted].

A JPay customer account under the name [Redacted] was created on March 25, 2023, and only in communication with Inmate [Redacted]. The JPay messages are romantic and sexual in nature. The JPay messages from the account detail [Redacted] for the purpose of getting pregnant with Inmate [Redacted]. Several references to sexual activity happening "again" were mentioned.

A JPay message sent on March 30, 2023, states, "I promise you; you can survive in my absence." and "I felt that dick, I know that for a fact." Inmate [Redacted] has been incarcerated with FDC since 2017, "you can survive in my absence" would not be new unless it was referring to the move Inmate [Redacted] made from Sergeant Moore. There are several pictures sent by the JPay account that match the same date and time of pictures on Sergeant Moore's social media page.

A phone number listed in a JPay message for Inmate [Redacted] to call [Redacted] is also a number that Inmate [Redacted] calls frequently on the recorded phone and that ViaPath account was created the same date the JPay message was sent with the phone number.

The recorded phone system ViaPath was checked, with the phone number [Redacted] (Provided in JPay message) and there has been 243 phone calls since April 6, 2023. One phone call made to the above number on May 1, 2023, at 2:54 pm was made from Inmate Levi Nelson's (Inmate Nelson) account. Video of the phone call time shows that Inmate [Redacted] is using the phone. On the other end of the phone, you can hear a male voice talking and the male voice states "you don't have to do this Tambrie." Inmate [Redacted] then tells Sergeant Moore on the line, "I'll call you back and let you have that conversation."

Assistant State Attorney Kathryn Land (ASA Land) was provided the details of this case as well as a copy of this affidavit for review. ASA Land advised she would support prosecution for the Introduction of Contraband.

Your Affiant respectfully submits probable cause has been established indicating Correctional Officer Sergeant Tambrie Moore did commit the violations of Introduction of Contraband - Written/Recorded Communication in violation of § 944.47(1)(a)(1) Florida Statute in Suwannee County.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
