The Undersigned Certifies and swears that he she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law:
 On the 5th day of May, 2023, at 4:00 pm (Especially include facts constituting cause for an arrest)

Your Affiant is Lead Senior Inspector Chris McGauley (LSI McGauley) with the Office of Inspector General (OIG) for the Florida Department of Corrections (FDOC), and the Defendant is Inmate Sammy Crenshaw (Inmate Crenshaw) DC# P41472 who was housed at Hamilton Correctional Institution Annex (HCI-A). Your Affiant has investigated an Aggravated Battery on a Law Enforcement Officer.

On May 5, 2023 in a sworn recorded interview, Correctional Officer [REDACTED] indicated [REDACTED]

In a sworn recorded interview Sergeant Molinski indicated when he arrived at Wing One (1), he observed [REDACTED] instructing Inmate Crenshaw to submit to hand restraints. Once the wing door was opened, Inmate Crenshaw exited the wing, into the Sallyport area, and attempted to exit the dormitory. A Use of Force occurred with chemical agents due to Inmate Crenshaw refused to comply with verbal commands. Inmate Crenshaw was placed on the floor and was placed in hand restraints after a brief struggle. At no time did [REDACTED] or Sergeant Molinski get struck by Inmate Crenshaw.

LSI McGauley reviewed the fixed-wing video and observed the incident as described by [REDACTED]. There is no fixed-wing video in [REDACTED] for LSI McGauley to review. During the interview with LSI McGauley observed [REDACTED].



Inmate Crenshaw was interviewed, post-Miranda, and denied the allegations against him.

The laundry bag with the lock inside of it was recovered, photographed, and placed into evidence at HCI-A.

Inmate Crenshaw was arrested by LSI McGauley and transported to the Hamilton County Jail by Deputy Yenson Gonzalez (*Deputy Gonzalez*).

Your Affiant respectfully submits probable cause has been established indicating Inmate Crenshaw struck [REDACTED] with a lock while he was acting in the capacity of a Correctional Officer. Inmate Crenshaw is in violation of Florida Statute 784.07(2)(d) for the crime of Aggravated Battery on a Law Enforcement Officer, committed at HCI-A, located in Hamilton County, Florida within the jurisdiction of the Third Judicial Circuit.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
