The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law:
 On the 9th day of September 2023, at 09:45 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Supervisor Jared Dewey with the Office of Inspector General for the Florida Department of Corrections. The Defendant is visitor Tiffany Lashon Jacobs (*Jacobs*) who entered upon the grounds of Hamilton Correctional Institution (Hamilton CI). Your Affiant has conducted an investigation into a Possession of Contraband – Controlled Substances.

On September 9, 2023, a Contraband Interdiction Unit (CIU) checkpoint was being conducted on the grounds of Hamilton CI to interdict the introduction of contraband. Jacobs approached the checkpoint and contact was made by institutional security staff through the open driver's window. Correctional Officer Captain Tyler Brown's (Captain Brown) K9 alerted to the presence of narcotic odor emanating from the vehicle driven by and solely occupied by Jacobs. Your Affiant was notified of the alert and then contacted Jacobs, still through the open driver's window. Your Affiant immediately smelled the odor of Marijuana emanating from the vehicle. Your Affiant informed Jacobs that the odor of Marijuana was smelled, and Jacobs freely [REDACTED] Jacobs surrendered a clear plastic bag containing a green leafy substance, within her reach, from the front passenger seat. The contents of this package were subsequently field tested for Marijuana and yielded a positive result for Marijuana. Additionally, she surrendered a cigar package contain a Marijuana cigarette. The total packaged weight of the Marijuana was 4.3 grams. Jacobs advised she has a Medical Marijuana, but the Marijuana was packaged in a clear plastic sandwich bag, not in the original prescription container as required.

Upon directing Jacobs to the side for a vehicle search, it was inquired of Jacobs if there was any further contraband or illegal narcotics in her vehicle. Jacobs hung her head and stated there was "Molly" that her son left in the car. Jacobs further stated she [REDACTED] Upon conducting a vehicle search, a green in color plastic baggie was located in the center console. The baggie contained an off-white powdered substance. Jacobs identified that baggie as the "Molly" she was referencing. The white powder was subsequently tested and yielded a positive alert for Synthetic Cannabinoids/Cathinones, BZP. The total packaged weight was 0.2 grams.

Jacobs had traveled from Ocala, Florida to Hamilton CI and had ample opportunity to dispose of the narcotics discovered during the vehicle search.

Your Affiant respectfully submits probable cause has been established indicating Tiffany Lashon Jacobs did commit the violation of Possession of Contraband – Controlled Substance in violation of Florida State Statute 944.47(1)(c) in Hamilton County, Hamilton Correctional Institution on September 9, 2023. Jacobs was subsequently arrested for one count of Florida State Statute 944.47(1)(c), Possession of Contraband - Controlled Substance.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
