

The Defendant did violate § 944.47(1)(a)(6) Introduction of Contraband, to wit:

Your affiant is Law Enforcement Inspector Michael Green #113026 with the Office of the Inspector General, Florida Department of Corrections

On September 24, 2019 Inspector Green was notified of a Correctional Officer found to be in possession of a cellular phone at Lowell correctional Work Camp. The officer was still present at the institution. Inspector Green responded to that institution and made contact with Correctional Officer Lieutenant Scott Confessore. Lieutenant Confessore stated that he was approached by Correctional Officer Heather Eckard, who reported seeing a cell phone under the shirt of Correctional Officer Ashley Holly. Officer Holly was asked if she had any illegal contraband on her persons by Lieutenant Confessore, to which Officer Holly produced a cell phone from her right jacket pocket.

Inspector Green reviewed video of Officer Holly entering the institution on September 24, 2019. The video shows Officer Holly enter the security check area, empty her pockets of items, remove her jacket and place everything on a shelf. Officer Holly did not submit her items to the security officer or the scanning machine. Officer Holly, put her jacket back on, gathered her items, walked around the metal detector and entered the secure perimeter. Once inside the perimeter, Officer Holly walked to the Lieutenant's Office to clock in, which occurred at 6:54 am.

At approximately 12:55 pm Officer Eckard reported seeing the cell phone concealed under Officer Holly's shirt while she was in the control room, behind the secured perimeter. Inspector Green was notified at 1:20 pm, via cell phone, by Lieutenant Confessore.

Inspector Green conducted a recorded interview with Officer Holly. Officer Holly was given Miranda Warnings, which she understood, waived and agreed to answer questions. Officer Holly admitted
