Your Affiant is Law Enforcement Inspector Steven Donaldson of the Office of the Inspector General, Florida Department of Corrections. Your Affiant has probable cause to believe that on June 15, 2019, at approximately 8:20 PM, FDC Correctional Sergeant Era Browning Huskey DOB did commit Malicious Battery to an inmate -									
According to Inmate and multiple inmate witnesses in the dormitory,									
that Inmate was attacking her. Inmate were documented Department of Corrections

The witnesses alleged the beating was part of a pattern of racism and bigotry by Sergeant Huskey towards inmates under her control.

Sergeant Huskey then submitted an official Florida Department of Corrections report about the incident with false information to cover up her actions. Sergeant Huskey reported that Inmate actually battered her by punching her in the face and pinning her to the ground, at which time she delivered multiple strikes to Inmate face and upper torso to prevent further harm to herself.

Sergeant Huskey subsequently ordered Correctional Officer Maggie Reyes to change her incident report twice in order to get the stories the same. Sergeant Huskey instructed Officer Reyes to rewrite her report to say that she saw Inmate on top of Sergeant Huskey, punching Sergeant Huskey and throwing Sergeant Huskey's radio away from her.

Officer Reyes testified that Sergeant Huskey ordered Inmate **Control** to bring a mattress to the dormitory laundry room. When Inmate **Control** did as he was instructed, Sergeant Huskey called Inmate **Control** into her "office" which was the inmate restroom area. Officer Reyes – who was in the officer station - then observed Inmate **Control** on top of Sergeant Huskey on the bathroom floor. Sergeant Huskey was holding Inmate **Control** by the arm. Officer Reyes pulled Inmate **Control** off of Sergeant Huskey without further incident. Officer Reyes never saw Inmate **Control** strike Sergeant Huskey or pin Sergeant Huskey to the floor as was reported by Sergeant Huskey. After the incident, Sergeant Huskey coerced Officer Reyes into changing her incident report to match Sergeant Huskey's report which she did not agree with.

On July 11, 2019, during a sworn recorded post-Miranda interview, Sergeant Huskey testified she delivered multiple strikes to Inmate face and upper torso area with a closed fist but maintained these actions were in self-defense due to Inmate face and upper torso area with a closed fist but maintained these actions were incident despite multiple witnesses who testified to the contrary.

Based on witness testimony and physical evidence, Sergeant Huskey falsified her report to conceal her malicious battery upon Inmate by reporting Inmate knocked her to the ground, punched her and threw her portable radio away. Sergeant Huskey subsequently coerced Officer Reyes into falsifying her incident report so that the reports would match. When questioned under oath regarding the incident, Sergeant Huskey perjured herself by knowingly making false statements to Inspector Donaldson while under oath.

Additional details are included in the criminal case summary report.

Your Affiant respectfully submits that probable cause has been established that Correctional Officer Sergeant Era Browning Huskey did commit the criminal offense of 914.22 (1)(b) Tampering with a witness, Florida State Statute 838.022 (1) (a) (b) Official Misconduct, Florida State Statute 837.012 (1) Perjury when not in an official proceeding and Florida State Statute 944.35(3)(a)1 Malicious Battery on an Inmate.
