



# Money Order Deposit Form

## For restitution & court-ordered payments

### Things to know before sending a payment.

There is no fee for sending money via money order, cashier's check, or certified bank draft.

All fields in the attached deposit form must be completed and legible to avoid a delay in processing the payment. Do not send cash, checks issued by businesses, employers, or through online bill paying services. Do not include any letters or notes with your payment because these will be discarded. Verify the offender's name and DC# are entered correctly on the money order, cashier's check, certified bank draft, and the deposit form.

We may reject your payment if (1) you did not include your name, telephone number, email, and mailing address, or (2) the amount of the payment exceeds the limits for the payment type. If we reject your payment, we will return the funds back to the address provided by you on the deposit form. You could also make a payment through the mobile app, website, or toll-free number.

## HOW TO SEND A MONEY ORDER, CASHIER'S CHECK, OR CERTIFIED BANK DRAFT



**Complete the Money Order Deposit Form** included at the bottom by typing or using blue or black ink. This deposit can be used for money order, cashier's check, or certified bank draft payments.



**Make the money order, cashier's check, or certified bank draft to CorrectPay.** You should include the offender's **full name** (first, last, and middle initial) & DC ID on the "memo" or "used for" line. We recommend using U.S. Postal Service® money orders.



**Place the money order, cashier's check, or certified bank draft and the deposit form in an envelope.**
