

In his incident reports dated September 7, 2009, and September 8, 2009, and his affidavit dated November 23, 2009, Officer John Chessher indicated the following:

He was assigned as a Q-dormitory housing officer and while making a security check in Quad 4, he approached cell 4208 where Inmate John Coley was housed alone. He observed that the window was covered and a visual check could not be conducted. He gave Inmate Coley several orders to uncover his cell window where Inmate Coley several orders to uncover the then reported this information to Sergeant Norris who retrieved a concave Plexiglas shield and returned to Inmate Coley's cell. Sergeant Norris gave Inmate Coley several orders to uncover his cell window, was observed hanging by the neck from the fire suppression sprinkler, with his hands loosely tied behind his back with a piece of torm sheet. Once the cell door was breached he assisted in lifting Inmate Coley to relieve tension from the torn sheet tied to the sprinkler head. He then assisted in removing the sheet around Inmate Coley's neck. (EXHIBITS A-3, A-4 & A-5)

In his incident report dated September 7, 2009, and his affidavit dated November 23, 2009, Sergeant Shawn Norris indicated the following:

He was assigned as Q-dormitory housing supervisor and Officer John Chessher advised him that Inmate Coley had his cell window covered and was approached cell Q-4208 with a Plexiglas shield and used it to cover the handcuffing portal to check on Inmate Coley's condition. Sergeant Norris observed Inmate Coley hanging with torn bed sheets from the sprinkler head. Sergeant Norris, Officer Chessher, Officer Cash and Officer Barnes entered the cell and the sheet was removed from Inmate Coley's neck and he was laid on the floor. Officer Cash

He was assigned as Q-dormitory housing officer and along with Officers Cash and Chessher, they were supervising the dayroom in quad four (4). Sergeant Norris, Officer Cash, Officer Chessher and Officer Barnes entered cell Q4208 and observed Inmate Coley hanging by the neck from a "makeshift" noose that was tied to the sprinkler head. He and Officer Chessher lifted Inmate Coley so Sergeant Norris and Officer Cash could remove the noose from the sprinkler head. Officers Barnes and Chessher placed Inmate Coley on the cell floor where Officer Cash

The "Pelco" fixed wing video of Q-dormitory quad four (4) was reviewed on September 7, 2009, and reflected the following:

Some of the officers were sitting at the dayroom table talking and some appeared to be doing paper work. An officer conducted security checks approximately **Constant of the security check** and he stopped at cell 4208 for a short time and then completed his security check. He proceeded downstairs and then staff responds to cell 4208. It appears that policy and procedure was followed by staff. **(EXHIBIT B-1)**

Note: The video camera does not have audio or direct footage inside of the cells.

In a review of the inmate telephone system Inmate Coley completed a telephone call on September 2, 2009, to his sister (Sharon Hayden #727-867-1019) and he indicated the following:

Inmate Ivory Minor called the "TIPS" line three times and indicated that Inmate John Coley was murdered, he did not hang himself and he was neglected.

In his sworn recorded statement of November 10, 2009, Inmate Ivory Minor indicated the following:

He indicated that he was sitting in the last interview room in wing four eating his "Ramadan" meal with Inmate Manuel and the officers were sitting at a table in the dayroom playing games. He heard Inmate Coley kicking on the cell door and yelling the second second second and the officers ignored him. Inmate Coley's cell window was covered. When the officers opened the cell door, Inmate Coley was lying on the cell floor with his feet towards the door. Officer Barnes Inmate Minor indicated that Inmate Coley did not hang himself. Inmate Minor also indicated that he called the "TIPS" line. (EXHIBIT B-3)

In his sworn recorded statement of November 10, 2009, Inmate Ian Manuel indicated the following:

He was in the center room in wing four with Inmate Minor eating their "Ramadan" meal, where the television is located. He heard an inmate yelling **Constant and the second second and second se**
