

around Inmate Turner and instructed the inmates to report to their rooms. At this time there was enough therefore she began securing the scene. (EXHIBITS B-1 & B-2)
In his affidavit taken on February 25, 2008, and in his incident report dated February 25, 2008, Sergeant Anthony Barker indicated that at approximately 10:20 AM, he observed Inmate Turner standing at the 'E' Dormitory entrance with Inmate Walker and Guzman patting him on the back. Sergeant Ferres advised him that Inmate Turner her radio was not working and she needed to use his radio. Sergeant Ferres called Inmate Turner was moved to the day room bench and at that time  Inmate Turner  Inmate Turner became

In his affidavit taken on February 25, 2008, Inmate Demetrius Walker indicated he was coming into 'E' Dormitory and overheard Sergeant Ferres When he came all the way into the dormitory he observed Inmate Turner sitting on the bench and he asked Inmate Turner Inmate Turner attempted to talk, He began beating on Inmate Turner's back and He began beating on Inmate Turner's back harder and then Turner He called Turner's name three times and observed Inmate Turner he was told to go to his cell.  (EXHIBIT B-5)
In his affidavit taken on February 25, 2008, Inmate Norwin Guzman indicated when he entered the dormitory at approximately 10:25 AM, he observed Inmate Turner sitting on the bench and Inmate Walker was attempting to help him. He observed Sergeant Ferres trying to call via radio; while he attempted to help Inmate Turner lay down on his side. Inmate Turner was  He assisted for a short time more and then went back to his cell due to an order by Sergeant Ferres. (EXHIBIT B-6)
In an incident report dated February 25, 2008, Officer James Estrada indicated at approximately 10:20 AM, while assigned as the 'E' Dormitory Housing Officer, Sergeant Ferres began banging on the Officer's Station window instructing him to call by radio, but Several staff members immediately entered afterwards.  (EXHIBIT B-7)

On February 25, 2008, Captain Justin Brennan submitted an incident report indicating at approximately 4:45 PM, he was advised by Sergeant Ed Hulin that Inmate Edward Turner, the inmate he and Officer Andy Ragan were supervising was pronounced dead was pronounced dead (EXHIBIT B-9)

An autopsy was conducted and Forensic Investigator John Rush indicated Inmate Turner died The manner of death is classified as accidental. A copy of the autopsy report will be made part of this investigative file when it is received.

No criminal or administrative concerns were brought up or observed during the investigation.
