**SUMMARY OF ALLEGATIONS:**

On December 17, 2010, a complaint was received from Captain Kenneth Crawford indicating that Inmate Salgat, Patrick DC# 200498, was observed on the floor underneath the rear stairwell of Gulf dormitory Wing three. Inmate Salgat was [REDACTED] Inmate Salgat was [REDACTED]

[REDACTED] Inspector Cataldi reports several witnesses alleged Inmate Robinson, Rickey DC# J16182, inflicted the injuries upon Inmate Salgat. This incident was reported via MINS on December 20, 2010, and assigned for investigation on December 21, 2010.

**SUMMARY OF DISPOSITION/JUSTIFICATION FOR DOWNGRADE/EXONERATION:**

As a result of this investigation, I am requesting this case be downgraded and closed. It has been determined that Inmate Salgat passed away at approximately 1750 hours on January 28, 2011, of [REDACTED] [REDACTED] Miami-Dade PD is pending investigative jurisdiction until the results of an autopsy; if results of the autopsy determines death to be ruled a homicide.

**FINDINGS:**

In an Incident Report of December 17, 2010, Captain Kenneth Crawford indicated the following:

At approximately 10:50am, on Friday, December 17, 2010, he heard Sergeant Ronald Morris make an emergency transmission via radio that there was an inmate on wing three of Gulf dormitory [REDACTED] and several inmates were in the area. When he arrived on the scene, Sergeant Daphanie Lee, Lieutenant Nathan Green, and Lieutenant Tishalyn Carlisle were securing the scene and keeping inmates out of the area so [REDACTED]

The inmate was identified as Inmate Salgat. Inmate Salgat was [REDACTED] Inmate Salgat was [REDACTED]

In a sworn Affidavit of December 28, 2010, Sergeant Ronald Morris indicated the following:

On December 17, 2010, while assigned as Gulf dormitory supervisor, he was in the officer's station observing wings one and two. Inmates were returning from the recreation yard for count so he and Officer Kahn were letting the inmates into their assigned area. When he turned around to allow wing three inmates in, he observed Inmate Salgat face down on the floor. Other inmates were yelling man down. He immediately [REDACTED] and security nine to alert the 'A' response team. There were multiple inmates in that general area at the time. (Exhibit A2)

On January 28, 2011, while [REDACTED] Inmate Salgat was pronounced dead by [REDACTED] Inmate Salgat's body was transported to the Union County medical examiner's office for an autopsy.

The medical examiner case number is ME11-58. A medical examination was conducted on Inmate Salgat on January 31, 2011, by Doctor William Hamilton. Inmate Salgat's [REDACTED] for further investigation. The medical examiner's office advised that the examination will be completed approximately 3 to 4 months from the date of Inmate Salgat's death.

Initial contact has been made with Miami Dade Police Department regarding Inmate Salgat's death. Detective Christy Kitts advised a determination for any further action to be taken by Miami Dade County will be made once the autopsy is completed. No case number will be issued at this time.

On April 22, 2011, I sent a request to the Union County Medical Examiner for a copy of the autopsy report. (Exhibit A4)

Upon receipt of the death certificate and the medical examiners report, an addendum to this report will be completed.
