| In his Incident Report and in his sworn affidavit, Correctional Officer Jose Rios indicated that on 10/04/11, at approximately 8:35 A. M., he was in the officer's station in Wing 1 of B Dormitory. He observed Inmate Gustavo Valdes assigned to B1116L, lying on his bunk covered with white sheets sleeping. At approximately , Sergeant Richard McManus entered the rear door of B Dormitory and indicated to him that he was going to conduct a security check of Wing 1 of B Dormitory. Officer Rios asked Sergeant McManus to wake Inmate Gustavo Valdes up for work. Officer Rios indicated that he observed Sergeant McManus approach Inmate Valdes's bunk. He heard Sergeant McManus give Inmate Valdes several verbal orders to get up and Valdes did not respond. He observed Sergeant McManus shake Inmate Valdes's shoulders in an attempt to wake him up and Valdes was still Sergeant McManus instructed him to call for  |

He knew Inmate Valdes very well, because they talked with one another on a daily basis. Inmate Mendieta indicated that Inmate Valdes rarely complained about anything. He knew that Inmate Valdes because Inmate Valdes told him. The witnesses indicated that they did not observe anything suspicious about Inmate Valdes prior to his death and they did not observe any suspicious activity occur at or near his living area on 10/03/11 or 10/04/11. | A review of the housing logs for B Dormitory indicates that on 10/03/11, at approximately conducted a master roster count. During that count, all of the inmates were alive and accounted for. There were no discrepancies indicated. Subsequent counts and security checks were conducted with no discrepancies noted.  |
