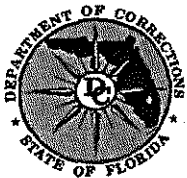

SUMMARY OF ALLEGATIONS:

On 2/26/09, at approximately 11:10 am, Inmates Trevor Grant, Kyan Bucknor and Aubray Hammett had an intentional physical confrontation with Inmates Michael Trammell, Daniel Rivera and Anibal Arrieta resulting in [REDACTED] and the death of Anibal Arrieta.

This is a supplemental report prepared to detail and describe this inspector's responsibilities and activities during the homicide investigation conducted under case number 09-50735. The primary investigative report will be prepared under the same case number by Lead Inspector Daryl J. McCasland.

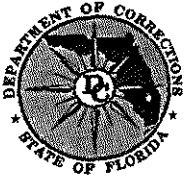

FINDINGS:

On February 27, 2009 at approximately 10:00am this inspector was contacted by Lead Inspector Marilyn Henderson and advised me to respond to Hendry Correctional Institution to assist in this investigation

On February 27, 2009, I arrived at Everglades Correctional Institution to pick up Inspector Tony Pesante and we departed that facility for Hendry Correctional Institution at approximately 12:00pm.

We arrived at Hendry Correctional Institution at approximately 2:00pm and met with Lead Inspector Daryl McCasland and Chief Inspector Doug Stevens. We were instructed to enter Hendry Correctional Institution compound to meet with Inspector Jeanne McLaughlin. Upon meeting with Inspector McLaughlin we were instructed to report to the multi purpose building where we to began interviewing inmates that were housed in B-dorm at Hendry Correctional Institution on February 26, 2009, to indentify witnesses for this case.

In a sworn recorded statement taken February 27, 2009, Inmate Miguel Hernandez indicated the following:

He did not witness this incident, but he heard the inmate who had been hit say that the person who hit him owed him money. **(Exhibit A-1, B-2)**

In a sworn recorded statement taken February 27, 2009, Inmate Tony Shaw indicated the following:

He saw some Hispanic inmates go upstairs in wing two about halfway down the wing, a confrontation happened and the Hispanic inmates ran back downstairs. He did not see what actually happened on the wing. **(Exhibit A-2, B-2)**

In a sworn recorded statement taken February 27, 2009, Inmate Jose Gonzalez indicated the following:

He did not witness this incident because he was at school. **(Exhibit A-3, B-2)**

In a sworn recorded statement taken February 27, 2009, Inmate Paul Akins indicated the following:

He did not witness this incident. **(Exhibit A-4, B-2)**

In a sworn recorded statement taken February 27, 2009, Inmate Cazu Solomon indicated the following:

Although he did hear that an incident was happening he did not actually witness this incident. **(Exhibit A-5, B-1)**

In a sworn recorded statement taken February 27, 2009, Inmate Amos Armstrong indicated the following:

He was at the Education Building when this incident occurred and did not witness anything. **(Exhibit A-6, B-1)**

In a sworn recorded statement taken February 27, 2009, Inmate Glen Bradley indicated the following:

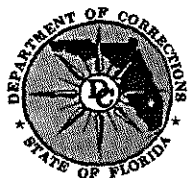
He was at work at the time and did not witness this incident. **(Exhibit A-7, B-1)**

In a sworn recorded statement taken February 27, 2009, Inmate Jose Bonilla indicated the following:

He did not witness this incident as he was he the Law Library at the time. **(Exhibit A-8, B-2)**

In a sworn recorded statement taken February 27, 2009, Inmate Ebrahin Gonzalez indicated the following:

He was watching television and did not witness this incident. **(Exhibit A-9, B-1)**

In sworn recorded statements taken February 27th and March 13th 2009, Inmate David Gadson indicated the following:

On February 26, 2009, he was on wing two in B-dorm getting his hair cut. While getting the haircut a big Latin inmate (he identified as "Heavy" and subsequently identified the picture of Inmate Michael Trammell) came to that area of B-dorm and stated to an inmate Inmate Gadson identified as Piper that he wanted his money. An argument started between the two and Inmate Trammell attempted to hit Piper. Piper then ran into his cell (cell 2214) retrieved a lock and hit Inmate Trammell. Inmate Trammell left the area and returned with other Latin inmates (one of the inmates Inmate Gadson identified the picture of Inmate Daniel Rivera). Another argument started between the Latin inmates and several Jamaican inmates including Piper and his cellmate Inmate Gadson identified as Sheik.

Sheik was armed with a two locks tied around a belt and began swinging the weapon striking Inmate Trammell twice. The Latin inmates began to retreat while being attacked by the Jamaican inmates. Eventually the inmates fighting and the onlookers were close to the area where you would enter wing two and out of the direct sight of Inmate Gadson. Inmate Gadson indicated that he did not witness anyone getting stabbed and did not see anyone with a shank or knife on February 26, 2009.

In a sworn recorded statement taken February 27, 2009, Inmate Timothy Hahn indicated the following:

At the time of this incident he was sitting in his room. He heard someone say it is going down on two-two wing. He looked out of his room but did not see what was happening and then returned to his room.

In a sworn recorded statement taken February 27, 2009, Inmate Edwin Garcial indicated the following:

He came in the dorm from school and stayed downstairs watching television. He heard a commotion going on upstairs. He stayed downstairs and did not witness this incident. **(Exhibit A-13, B-1)**

In a sworn recorded statement taken February 27, 2009, Inmate Renard Dubuisson indicated the following:

He was playing dominoes upstairs by wing three and saw inmates running from wing two but from his position he did not see the incident occur. **(Exhibit A-14, B-2)**
