#### FINDINGS:

In his Incident Report dated March 22, 2012, Officer John Perez indicated the following:

While inside the F-dormitory officers' station, he observed, inside wing 1, Inmate Rivas standing in front of cell F1-220. Inmate Rivas appeared to be struggling with someone inside the cell. Inmate Rivas exited the cell and turned towards the officers' station. After observing, Inmate Rivas' shirt had been he (Perez) responded to wing 1. Upon observing Inmate Rivas walking torn and towards the back of the wing, he (Perez) went up the back staircase, placed Inmate Rivas in hand restraints and secured the inmate inside cell F1-218. He (Perez) then walked over to cell F1-220 and observed Inmate Williams laying on the floor face up, He (Perez) and four other inmates Inmate Williams, and escorted the inmate He (Perez) then removed Inmate Rivas from cell F1-218 and escorted the to (Exhibit A-1) inmate to

According to the Miami-Dade Police Report, dated March 22, 2012:

A fight, witnessed by a correctional officer (John Perez), occurred inside cell F1-220 between the decedent Inmate Williams and the subject Inmate Rivas. The officer observed both Inmate Williams was transported to the off the Inmate Williams and Inmate Rivas. Inmate Rivas was detained and Inmate Williams was transported to the off the Inmate Williams (Exhibit A-2)

A 6-7 inch shank was located inside the pipe chase (plumbing room) between cells F1-111 and F1-112. The weapon was placed into evidence by Miami-Dade Police Department.

On March 23, 2012, Inmate Rivas was transferred to Florida State Prison.

On April 12, 2012, Miami-Dade Police Department conducted additional interviews with several inmates housed inside F-dormitory Wing 1 during this incident.

According to Miami-Dade Police Detective Ray, a request for an arrest warrant on Inmate Rivas has been made with the Miami-Dade State Attorney's Office and is pending.
