SUMMARY OF DISPOSITION/JUSTIFICATION FOR DOWNGRADE/EXONERATION:

The Palm Beach County Sheriff's Office (PBSO) was notified and assumed investigative jurisdiction (Case # 09-144054). Inmate Willie Smith was pronounced dead on October 24, 2009, at approximately 1148 hours. Inmate Vincent Lee was placed in Administrative Confinement pending investigation. On October 26, 2009, a warrant was issued for the arrest of Inmate Vincent Lee on charges of First Degree Murder, Introduction of a Weapon into a Correctional Facility and Destruction of / Tampering with Physical Evidence.

In a sworn, taped statement taken on October 16, 2009, Inmate Vincent Lee DC # 096896 signed a Rights Acknowledgement and declined to make a statement. (Exhibits A-8 & B-1)
